He rejoined the SIA Group as senior manager, corporate accounts and financial planning, with SIA Cargo Pte Ltd, a wholly-owned subsidiary of SIA (2001 – 2005) where he was responsible for raising long-term financing for the company's freighter acquisition program as well as financial reporting to the SIA Group.

Mr. Cheong holds a Master of Applied Finance degree from Macquarie University, Australia (1997 – 1998) and a Bachelor of Accountancy (Second Class Honors) degree from the National University of Singapore (1985 – 1988).
